Thank God for Cops

- When police aren't there, all neighborhoods suffer
- Reform—but don't gut or abolish—police departments

America's law enforcement officers and agencies have been under attack from the radical left for decades. Demonized as over-zealous thugs and violent brutes, cops are constantly criticized and scrutinized while operating in some of the most difficult circumstances and dangerous environments.

In the aftermath of the shocking murder of George Floyd, a previously convicted armed robber and multiple drug offender, at the hands of Minneapolis policemen, one of whom appears to have been a rotten apple, the radical left has pushed their anti-cop rhetoric and agenda to a new level. A movement to defund and even dismantle police departments has gained traction in recent weeks, as Black Lives Matter and other radical leftist activist groups demand a revolutionary restructuring of American society. This particularly relates to law enforcement and the criminal justice system, based on the mythology of "systemic racism" and widespread oppression of and police brutality against blacks.

Activists and many politicians are now calling for a reduction in police budgets across the country, and an increase in funding for social services programs, healthcare, education, and housing, particularly for minorities, immigrants, and other "disadvantaged" communities, such as illegal aliens.

In Minneapolis, where Floyd was killed late last month while in police custody, nine of the 13 members of the city council publicly announced their support for entirely defunding and dismantling the city's police department.

"We have committed to dismantling policing as we know it in the city of Minneapolis and to rebuild with our community a new model of public safety

that actually keeps our community safe," Council President Lisa Bender explained to CNN recently. "[We need] to listen, especially to our black leaders, to our communities of color, for whom policing is not working and to really let the solutions lie in our community." Bender and her deluded allies on the city council are seeking a "transformative new model of public safety" and want to divert funding from traditional policing to "community-based strategies."

Other cities have jumped on board. Officials in Los Angeles have pledged to reduce police funding and to invest more resources in black neighborhoods and other "marginalized" communities. Mayor Eric Garcetti recently committed to identifying "\$250 million in cuts so we can invest in jobs, in health, in education, and in healing" at a press conference, pledging to divert the money toward minority groups. But must it come from the police budget?

"It is time to move our rhetoric towards action to end racism in our city," Garcetti declared.

President Donald Trump, some Re-

publican leaders, and law enforcement officials have condemned the proposals from the radical left and their enablers in government as a direct threat to law and order in America.

At a recent press briefing, White House Press Secretary Kayleigh McEnany argued that if "you eliminate police officers, you will have chaos, crime, and anarchy in the streets." Attorney General William Barr described the agenda as "wrong" and said that it is "dangerous to demonize police."

While police brutality and misconduct do occur—which can be corrected with better training—the notion that law enforcement is an oppressive, evil institution enforcing "white supremacy" is an absurdity perpetuated by the radical left in its transparent effort to transform American society to cater to the demands of a misguided minority. Black communities in particular will suffer if police departments are abolished, though there are areas where police budgets in some cities could be trimmed in a manner that would not put citizens at risk. ★

It has been particularly bad in the week following the riots and looting that plagued major cities across the United States, as conservative voices have been largely silenced. Worse, most Republicans have unquestioningly fallen in line without raising a hint of objection.

Liberal voices are now dominating the discussion of the most important topics facing this nation, defaming, condemning, alienating, de-platforming, slandered and even firing anyone who doesn't toe their line.

Overwhelmingly, true conservative voices are being shouted down as liberals, who once just simply asked for equality, now call to upend capitalism, cede individual choice to the government over critical issues like medicine, crush free speech and even get rid of entire police forces in the most violent cities in America.

What world is this that we're living in? All one has to do is open a local newspaper or turn on the news to see what we are talking about.

Those who are still fighting the good fight on news networks like Fox, have had to face relentless pressure to fall in line or be ostracized from society. Even hugely popular conservative icons like Tucker Carlson, who has millions of followers including President Donald Trump, has been told to temper his opinions or face an advertising apocalypse. Ad-

vertisers are just too scared to tussle with Black Lives Matter.

The situation would be hysterical were it not so serious. Top Democrats have been staging photo ops and groveling on national television, going so far as to don African garb—without even knowing anything about the clothing or the different histories of the African tribes and groups they are appropriating. It amounts to nothing more than a shameless, cynical ploy to garner minority votes. Everyone—from those who are actually doing it to those who are broadcasting it—knows this to be true. We have seen videos of groups of white demonstrators and even policemen washing the feet of black religious figures while shouting cringing apologies into a megaphone.

For us, nothing graphically demonstrates the current state of politics in America than a video posted to the Internet that shows a group of young white activists in Washington, D.C., angrily lecturing a black woman about "systemic racism." The white protesters ignore the black woman when she fires back that, if they really cared about black lives, they would be in Chicago working to end black-on-black violence, repeating their mantra that she doesn't really understand what black people face today—as if white liberals from rich suburbs could comprehend it.

If you ask what these brainwashed zombies are apologizing for, you will invariably face a tired, lengthy lecture

loaded with hundred-dollar phrases like "systemic racism," "critical race theory," and "oppression." They cry out for "change," but, when pressed, cannot clarify solutions.

If you ask for details and specific examples, you will hear colorful stories repeated over and over that, at their heart, amount to nothing more than someone being mean to someone else. God forbid you respond to these arguments with facts that demonstrate the country is not fundamentally racist and that the solutions to inequality largely rest within communities themselves.

All of this is ironic when one considers that nearly every Democrat-led state and city—even those with Democratic black mayors, city councils, and law enforcement—have failed to lift their poorest constituents out of poverty, and, in many cases, have actually seen life get worse for all minorities who live there.

It used to be that everyone just accepted that a person needed to hear the truth before they could understand what was wrong and take the necessary steps to fix what is ailing them. Today, however—to paraphrase George Orwell—telling the truth has become a revolutionary act.

Luckily, there are people and organizations out there like AFP who are willing to tell the truth, including a host of brilliant black conservatives, who know this is nothing but upper-middle-class white liberals trying to soothe their fragile egos while in-

fantilizing poor people of all races.

Instead of asking, "What is it that can actually help these communities?" they are again—as they have for decades—only asking, "What more can we give you to appease you?"

What will really help the black community—and the white and Hispanic, as well—is the truth and America-first policies. We need jobs and more opportunities for individual advancement, not more concessions.

They are part of the problem, not part of the solution. They are dangerous.

News You May Have Missed

Fake Hate Crime Outed

In AFP's March 9 & 16 issue, writer John Friend reported on growing concerns surrounding an alleged hate crime committed at Salisbury University in Maryland in the fall of 2019. At the time, AFP reached out to police and prosecutors to find out more, as news reports indicated law enforcement had detained a suspect. Officials were tight-lipped on details, and now we know why. On June 8, it was announced that 54-year-old Jerome Kevin Jackson will be pleading guilty to charges related to racist graffiti that was written on walls at the university. Jackson, who is black, has a long criminal history, including charges of burglary and possession of illegal drugs. Jackson has admitted that he is responsible for the racist graffiti that was found on the campus over the course of multiple days. At the time, school administrators shut down the campus and students were allowed to go home after a couple racist words were discovered on the walls of a bathroom and the library.

Rights Under Threat

Some cities in the U.S. are moving to limit or even outright ban gun sales in the wake of violent demonstrations that sparked riots and looting across the United States. For example, on May 31, Keith James, the mayor of West Palm Beach, Fla., declared a state of emergency that, per state law, banned all firearms and ammunition sales and negated the right of citizens other than law enforcement to carry a firearm in public, so long as the order is in effect. Extended once by a vote of the city commission, the mayor lifted the state of emergency on June 8. The move comes as more and more Americans—even many liberals—are buying firearms for their own personal protection, a right guaranteed to everyone under the Second Amendment.

Tragic Black-on-Black Violence

Over the course of the weekend of June 5-7 in St. Louis, 21 people were shot, six of whom were killed, reports conservative news and commentary website "Breitbart News." Prior to that, 17 individuals were shot in that city within a 12-hour window from May 23-24. Two of those shooting victims died of their wounds. All of the victims are black men and women.

Leaving and Never Coming Back

With downtown Minneapolis still smoldering less than a week after rioters and looters targeted nearly 1,000 businesses in a five-mile area, some business owners are already announcing they're leaving and taking their companies with them. Chicago's *Star-Tribune* interviewed Kris Wyrobek, president and owner of 7-Sigma Inc., whose building was heavily damaged during the pro-

tests. He said employees watched a neighboring affordable housing complex under construction burn to the ground while "the fire engine was just sitting there, but they wouldn't do anything." He added, "They don't care about my business. . . . They didn't protect our people. We were all on our own." The police and fire departments were reportedly told to stand down by city officials so that protesters could blow off steam. According to the *Star-Tribune*, "The city's first survey of property damage shows that nearly 1,000 commercial properties in Minneapolis were damaged during the riots, including 52 businesses that were completely destroyed and 30 other locations that sustained severe damage. Owners and insurance experts estimate the costs of the damage could exceed \$500 million."

Gun Rights Matter

The liberal media has dedicated considerable editorial space to blasting the mostly white protesters in Michigan who are demonstrating against the Covid-19 lockdown, because some of them legally carry firearms. Left-wing commentators argued that, had black people showed up to protest with weapons, racist cops would have



immediately arrested them or, worse, murdered them all. These newsmen, who have their heads firmly stuck in their echo chambers, must have missed all of the videos posted to social media that showed heavily armed black Americans at the height of the riots and looting in Minneapolis flexing their Second Amendment rights by protecting local stores and others' homes with guns. There were no reports of these armed, law-abiding citizens being detained, let alone harassed, by police. Good for them.

A Deafening Silence

While protesters across the United States were rioting and demonstrating over the purported systemic oppression of black people at the hands of whites in the United States, in the city of Chicago, over the course of one night, 18 black people—including a father, a high school student, and a college graduate—were murdered at the hands of criminals, not one of whom is white.

Even more shocking, the *Chicago Sun-Times* reports that, from 7 p.m. Friday, May 29, through 11 p.m. Sunday, May 31, 25 people were killed in the Windy City, with another 85 wounded by gunfire. It is the worst violence the city has seen in 60 years.

Foot-Washing Fetish

In perhaps one of the most ridiculous displays to come out of the recent protests, white demonstrators and even a few white police officers in Cary, N.C., put on a show for onlookers as they got on their knees before two purported black "faith leaders," removed the shoes of the black man and woman, and then took turns washing



the couple's feet and apologizing for their supposed sins. In a video posted online, a white protester can be heard saying into a megaphone, "We repent on behalf of Caucasian people," as a dozen white people can be seen in the background washing the feet of the black man and woman.

Hitting the Bricks

Early reports showed pallets of bricks had been left mysteriously on sidewalks at the height of protests in cities in Texas, California, Virginia, and Massachusetts, leading some on the internet to speculate that Antifa or other radicals were behind efforts to encourage more violence and property damage during the demonstrations. The website "FactCheck.org," however, collected multiple news reports that debunked these theories. In all the instances cited, local news outlets were able to identify the pallets of bricks as belonging to construction companies that were in the process of making repairs to buildings and sidewalks just before the demonstrations kicked off. This does not mean that bricks were not brought to the protests by Antifa members. What it means is that, thus far, large deliveries of bricks in pallet form cannot be proven to have been orchestrated by the anarchist group. They did bring backpacks filled with crow bars and hammers with which to smash shop windows, remove plywood protecting boarded-up shops, and hand out to looters.

Listen & Learn from Black Americans

• Owens, Elder, Sowell, Woodson etc. have important things to say about current events

For anyone who followed the recent protests and riots closely, the rallying cry for many has been to “listen to and learn from black Americans.” That conversation can be a very different one, however, depending on whom you listen to.

Take young black activist Candace Owens, for example. Few individuals today have had to face the kind of disgusting vitriol on the internet that is regularly lobbed at Owens, but this fearless young woman gets out there every day to voice her reasoned opinion on social media platforms, despite the fact that all of these are overwhelmingly dominated by far-left-wing activists.

On June 9, Owens led the charge, sharing a ridiculous video of Speaker of the House Nancy Pelosi (D-Calif.), Sen. Chuck Schumer (D-N.Y.), and other top Democratic officials, dressed in African garb and “taking a knee” for eight minutes in the U.S. Capitol.

“I have to say—I thought there was at least one or two things that the Democrats wouldn’t stoop to for the black vote, but there is apparently nothing,” she wrote on Twitter. “Dressing in African garb and getting on their knees for a photo op because it’s only four months to November.”

On June 7, she fired off a tweet on Twitter in response to the violent protests and the calls for white Americans to cave to the left’s increasingly insane demands.

“If you believe everything that is wrong with black America is the fault of white people, then you believe in white supremacy,” she wrote. “If you believe blacks will only get better by and through the actions of white people, then their supremacy is implied. I’ve never bought into that.”

In perhaps her most attacked comment to date, Owens wrote about George Floyd, who was asphyxiated by police after trying to buy cigarettes with a fake \$20 bill, sparking the protests, looting, and other violence.

She wrote: “Guess my message to little kids would be for them not to idolize men that get high on fentanyl, get high on meth[amphetamine], use counterfeit bills, shove guns into the stomachs of pregnant women while robbing them, go to prison five times. What a truly horrible message I carry.”

Owens has faced hateful verbal abuse over that statement as well as a video that questioned why liberal and black activists took to the streets to protest and riot because of Floyd, who went to prison for years after he pointed a gun at the belly of a pregnant woman before robbing her in 2007.

An autopsy showed that Floyd, who had supposedly changed his life following his time in prison, was high on fentanyl and had recently used methamphetamines when he was killed at the hands of police.

Owens has stated that Floyd obviously did not deserve to die for passing off a fake \$20 bill. She is only questioning why left-wing activists and blacks are destroying their own neighborhoods while making a hero of this clearly very troubled man.

Owens was recently kicked off the crowdfunding website “GoFundMe.” The company claimed her campaign constituted “intolerance,” charging that it violated the company’s terms of service, specifically “user content that we deem, in our sole discretion, to be in support of hate, violence, harassment, bullying, discrimination, terrorism, or intolerance of any kind.” Owens had been raising money for the Parkside Café in Birmingham, Ala., owned by a conservative man. Michael Dykes, the founder of Parkside Cafe, had called Floyd a “thug” and said protesters were “idiots” in a private text message sent to the co-owner of the bar as well as one of Parkside’s employees. Dykes’s text message was shared with others and eventually was posted to Facebook by a disgruntled employee. Not surprisingly, the backlash has effectively destroyed his business.

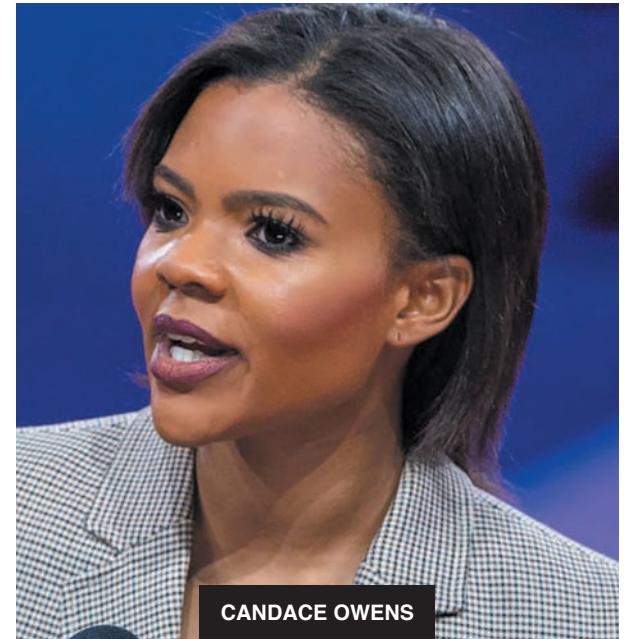
Owens had managed to raise over \$200,000 for Dykes before her campaign was arbitrarily shut down by “GoFundMe.”

Owens is but one of many black conservatives who have been spent decades fighting left-wing lies.

Talk show host and author Larry Elder is another and is featured on page 8 in this week’s issue. Elder recently took to Twitter to destroy liberal claims concerning “systemic racism” and “oppression,” writing, “Assume there’s a vaccine against white racism. Would 70% of black kids still be raised in fatherless homes? Would 50% of blacks still dropout of many urban high schools? Would 25% of young black urban men still have criminal records? Would blacks still kill 7,000 blacks every year?”

Thomas Sowell is yet another voice to listen to. Considered by many to be the godfather of conservative black activism, Sowell, even at the age of 89, is still active on social media, taking down liberals head-on.

On June 7, Sowell hit back hard against left-wing activists and what he calls “race hustlers,” writing on Twitter, “People sometimes ask if I

have tried to convince black ‘leaders’ to take a different view on racial issues. Of course not. I wouldn’t spend my time trying to persuade the mafia to give up crime. Why should I spend time trying to convince race hustlers to give up victimhood?”

A day earlier, he chimed in with the following chestnut: “Achievement is not what liberalism is about. Victimhood and dependency are. Many things that would advance blacks would not advance the liberal agenda. That is why the time is long overdue for the two to come to a parting of the ways.”

Robert Woodson is another black conservative who has risen to considerable success. A former senior advisor for President George W. Bush, Woodson has been making the rounds on network news television lately to offer his opinions on the recent protests.

“Black Democratic leaders make the false claim that the problems of unemployment, out-of-wedlock births, and crime are associated with this country’s legacy of slavery and discrimination,” said Woodson. “That’s another lie.”

In a recent interview on Fox News, Woodson argued that “institutional racism” is a ruse.

“The great promise was that if you just elected blacks to those offices, the inequities would improve,” he told Fox News. “We’ve spent about \$22 trillion over the past 50 years of government money—where 70% goes not to the poor but those who serve the poor. Blacks have been in office, and conditions for low-income blacks have deteriorated every year. One of the ways the leaders use to explain this decline is they use race as a ruse.”

There are many more black conservatives out there besides these figures—voices that should be heard over the chaos, looting, vandalism, and arson that has dominated the news cycle in early June. ★

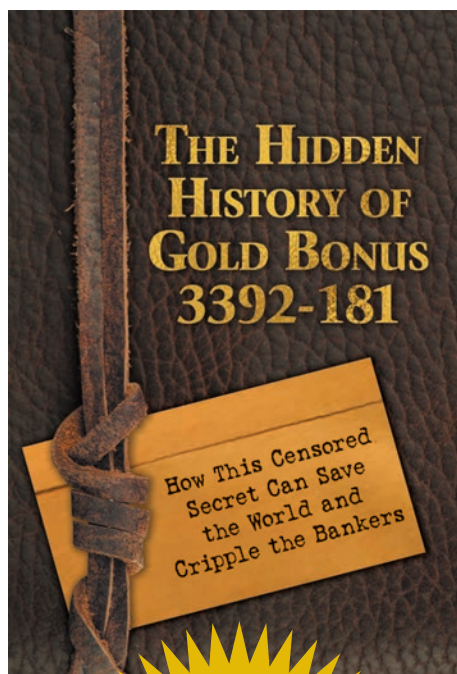

MORE VOICES FROM BLACK AMERICA SPEAK OUT

Not All African Americans See Things the Same Way

Perhaps the most maligned group in America, next to “white supremacists,” is black conservatives. They are routinely derided as “Uncle Toms,” or “not really black,” or “traitors to their own race.” Thomas Sowell, a senior fellow at Stanford University’s Hoover Institution, has written more than 30 books from a libertarian perspective. Sowell has written about America’s “moral bankruptcy” and focused on the censorship flourishing on all college campuses, which denies conservatives and independents a chance to express alternative views.

Larry Elder, another high-profile black conservative, reacted angrily to Twitter restricting another user for merely mentioning the name of his controversial new film “Uncle Tom.” The documentary, sure to be shunned by polite society, “is a collection of intimate interviews with some of America’s most provocative black conservative thinkers.” At some point in their lives, each cast member has been called an Uncle Tom. Floyd’s girlfriend, Courtney Ross, urged residents to stop looting and burning in his name.

James Meredith is remembered for being the first black student admitted to the segregated

University of Mississippi. President John F. Kennedy had to call out the National Guard to ensure his admission and quell riots. Meredith underwent an unexpected transformation, culminating in his 1989 appointment to extremely conservative North Carolina Republican Sen. Jesse Helms's staff as a domestic adviser. Black leaders reacted predictably, soundly castigating him for working for the former outspoken segregationist. Meredith explained that he'd applied to every member of both the House and Senate, and only Helms's office responded. On the 40th anniversary of his college admission, Meredith had to have armed military personnel to protect him as he attended the ceremony.

Few Americans realize that Pat Buchanan, lambasted as “racist” himself by many on the left, nominated a now forgotten black woman, Ezola Foster, as his vice-presidential running mate on the 2000 Reform Party ticket. Foster had become an outspoken critic of pornography, sex education, and the like, founding the organization Black Americans for Family Values in the 1980s. Dash also proclaimed that transgender rights infringed upon her own rights. She was hired by Fox News, but eventually became too controversial and was fired. Dash supported Donald Trump in the 2016 election.

While the state-controlled media permits only an embarrassingly limited range of views on all topics, for blacks the parameters are even more restricted. The same destructive hive mentality that shames young blacks into thinking that reading and studying are “acting white,” heaps collective scorn upon individuals who aren't on board with the “all whites are racist” defeatist mentality.

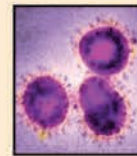

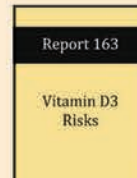

No Systemic Racism, Says Elder

• Militant wing of BLM ignores some pretty important facts

Black lives matter. Black businesses, not so much. Four Minneapolis cops were summarily fired, with one of the four arrested and charged with the murder of a black suspect named George Floyd, who died in police custody.

In cellphone video apparently taken by one of the many witnesses, a cop later identified as Derek Chauvin placed his knee on Floyd's neck for almost nine minutes as Floyd laid face-down and handcuffed on a city street. The cops ignored Floyd's repeated plea, "I can't breathe." By the time paramedics arrived, Floyd was unresponsive and apparently lifeless. After about an hour of attempted resuscitation by EMTs and emergency room staff, he was pronounced dead.

As of this writing, there have been eight consecutive days of protests in the streets of Minneapolis, with many businesses attacked, looted, and set on fire. The local district attorney is continuing the investigation and may file additional charges against the officers. But this has not stopped the protests, many violent, that broke out in other cities across the country, including Los Angeles, Washington, D.C., and Atlanta.

Ostensibly, the protests are about the alleged "epidemic" of "widespread" and "race-based" police brutality against blacks and the lack of confidence, in the case of Floyd, that justice will be done. The problem with these assertions is that they are false, not supported by the data.

There is no "epidemic" of racist cops killing black suspects. According to the Centers for Disease Control and Prevention, police killings of blacks declined almost 80% from the late 1960s through the 2010s, while police killings of whites have flatlined. Meanwhile, in 2017, according to the CDC's National Vital Statistics Reports, non-Hispanic blacks were eight times more likely to be a victim of a homicide (homicide death rate:

23.2 per 100,000) than non-Hispanic whites (homicide death rate: 2.9 per 100,000).

The No. 1 cause of preventable death for young white men is accidents, like car accidents and drownings. The No. 1 reason for death, preventable or otherwise for young black men, is homicide, almost always at the hands of another young black man. In 2018, there were approximately 7,400 black homicide victims, more than half of the nation's total number of homicides, out of a black population of 13%. Of that number, the police killed a little over 200 blacks, and nearly all of them had a weapon or violently resisted arrest.

In recent years, the police have averaged killing about 1,000 Americans per year. Of that number, half are white and one-quarter are black, with the race of remaining suspects of another race or unknown. Of the approximately 1,000 killed by cops, less than 4% involve a white officer and an unarmed black man.

Recent studies not only find no "systemic" abuse of black suspects by the cops, but if anything, cops are more hesitant, more reluctant, to use deadly force against a black suspect than against a white suspect. The Manhattan Institute's Heather MacDonald writes: "Regarding threats to blacks from the police: A police officer is 18.5 times more likely to be killed by a black male than an unarmed black male is to be killed by a police officer." Last year, according to *The Washington Post*, the police killed nine unarmed blacks. They killed 19 unarmed whites. In recent years, about 50 cops have been shot and killed annually in the line of duty. So, more cops are killed each year than are unarmed black suspects.

Minneapolis in 2020 is not Birmingham, Ala., in the 1950s. The top cop is not a racist segregationist like Birmingham's infamous Bull Connor, who sicced dogs and turned water hoses on civil rights protesters. The police chief of Minneapolis is Mexican-American and black. The mayor is a young Democratic liberal. The district's U.S. House representative is black. The vice presi-



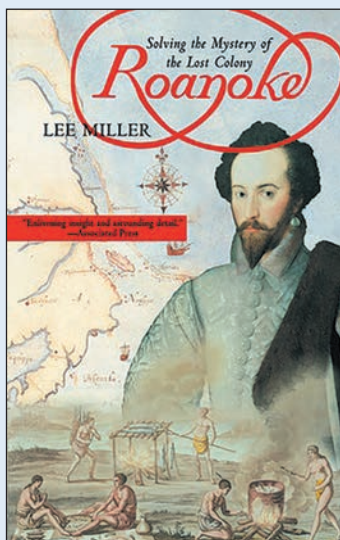
dent of the city council is black, as is the state attorney general.

In 2015, in Baltimore, where a black man named Freddie Gray died in police custody, how could one, with a straight face, argue that resident blacks suffer from "institutional" racism? The mayor was a black female; the top two officials in the police department were black; the city council was majority black; the state attorney who brought the charges against six officers was black; three of the six charged officers were black; the judge before whom two officers tried their cases was black; the U.S. attorney general was black, as was the president of the United States. Institutional racism?

Finally, why didn't President Barack Obama's administration deal with this alleged "systemic" or "structural" or "institutional" police brutality against blacks in his eight years in office? Meanwhile, over Memorial Day weekend in Obama's adopted hometown of Chicago, 10 people were killed, and 49 were shot. In a city where roughly one-third of the population is black, 70% of the city's homicide victims, according to the Chicago Police Department, are black.

When and where do the protests begin? ★

Police Killing People of All Races, But the Truth Has Been Hijacked

From 2017 and into 2020, American law enforcement officers have killed 2,855 civilians. Of those, 1,268 were white, 518 were black, 498 were Hispanic and 571 were “unknown” or “other.” It takes quite a leap of logic to draw from those numbers a mantra that “white cops are targeting black people for death,” given the fact that many of these shootings were carried out by black police officers.

The numbers should be compared to the startling prevalence of black-on-black crime. In 2015 alone, the last year complete data appear to be available, some 2,380 blacks were killed by other blacks. In many cases, the race of the perpetrator is not definitively known, so the actual figures are undoubtedly higher. Overall, blacks have accounted for over half of all homicide victims every year since 2010. The vast majority of them were killed not by police officers but by other black people. It is not racism to relay these statistics, but truthfulness.

The riots and protests occurring across this country have been portrayed in the state-controlled media as being exclusively about race, and more specifically, about “white privilege” and “white supremacists.” Regardless, the widespread looting, arson, and destruction of property have been overtly supported by left-wing journalists and politicians alike. Violent groups like Antifa and Black Lives Matter are front and center, literally stoking the flames.

The entire press went ballistic when Donald Trump posed in front of St. John’s Church—known historically as the “church of presidents,” while holding up a Bible. It was an identical pose, in the exact same spot, that Bill Clinton struck in a photograph several years ago. Police had fired tear gas in an effort to clear a crowd, so that Trump could walk freely to the church. While the president was castigated for this, little mention was made of the fact that he was posing in front of a church that had been damaged by protesters. Washington Bishop Mariann Budde reserved criticism for the president exclusively, dismissing the damage to the church as minimal, and calling Trump’s actions “an excruciating moment.” Budde also declared that Trump “is not entitled to use the symbolism to promote an entirely different message” from the protesting “people of color.”

There has, however, been virtually no criticism of those doing the looting, burning, and destroying of property by any media outside of Fox News. CNN anchor Don Lemon, who is basically an Antifa spokesman in the guise of a news anchor, replied to fellow “journalist” Chris Cuomo’s reference to “passion that fuels anger that fuels change.” He proclaimed:

After a while, people say, “Look, I’m tired of this. I’m tired of it, and either you let me in, you

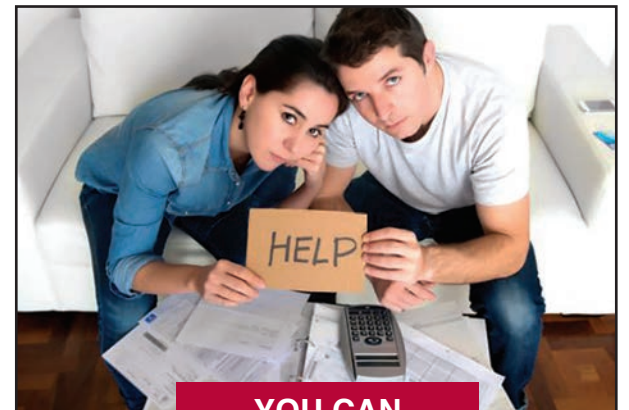
understand me. I’m gonna force my way into the conversation. Force my way into the system. I’m gonna demand that you let me into the house,” meaning—I’m talking about—you get what I’m saying, the metaphorical house. And you’re going to have to do it, and people aren’t going to like it. So, why can’t we all figure out how to do it now instead of an insurrection that happens because no one wants to change?

Showing that he was every bit as deluded, Cuomo editorialized against the civil disobedience of Henry David Thoreau, Mahatma Gandhi, and Martin Luther King Jr., declaring, “Please, show me where it says that protests are supposed to be polite and peaceful. Because I can show you that outraged citizens are what made the country what she is and led to any major milestone. This is not a tranquil time.” The First Amendment, of course, protects “the right of the people peaceably to assemble.”

Donald Trump Jr. responded to Cuomo on Twitter, mentioning the retired black former St. Louis police captain killed by protesters: “Here’s CNN’s Chris Cuomo carrying water for violent criminals burning down communities and saying that he doesn’t think protests are supposed to be ‘peaceful.’ Imagine saying that less than a day since Capt. David Dorn was killed in cold blood by looters?”

What should be focused on is just how many people of all races police have killed, and the number of those killings that appear unjustified to any reasonable mind. In contrast, consider that police in Norway haven’t killed a single person in over a decade.

Whatever comes out of these protests, on the heels of an unprecedented shutdown of the country, is not likely to be pretty. ★

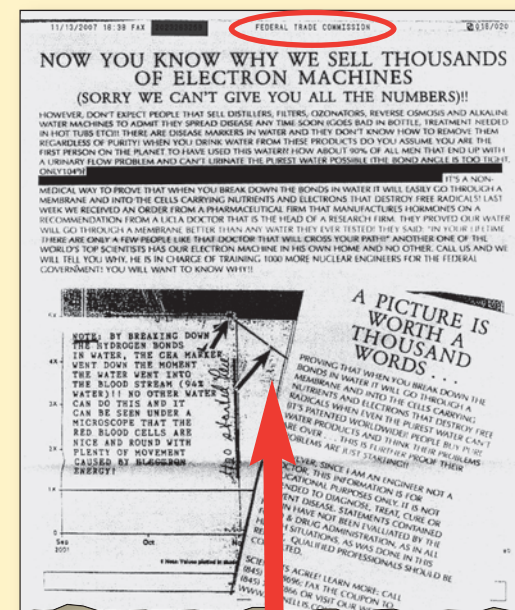

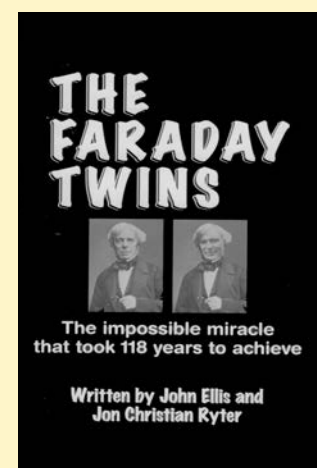

But, of course, nobody in the privileged mainstream ever makes that connection. To even suggest that working-class Americans of all races were silently screaming, “I can’t breathe,” during the lockdown is to commit treason and heresy against two articles of mainstream faith: that the lockdown was a good thing, and that the slogan “I can’t breathe” must be reserved for the Black Lives Matter movement.

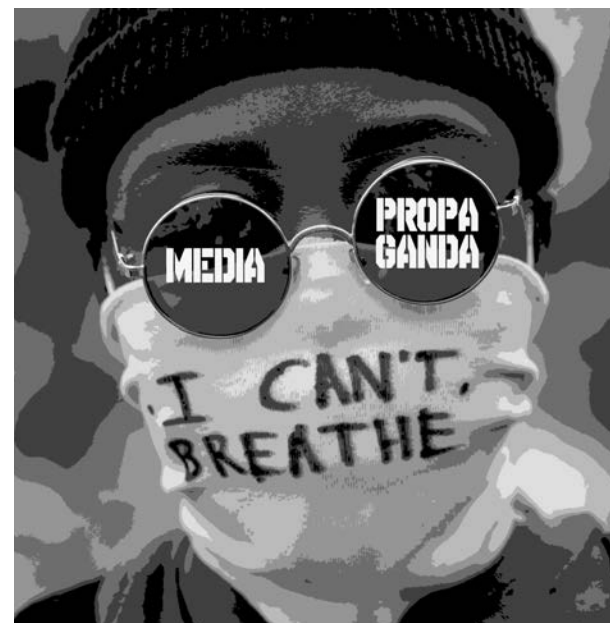
Taking this analysis one step further, we might wonder whether “I can’t breathe (due to police brutality)” is being promoted so relentlessly in the mainstream media precisely because it replaces the painful memory of “I can’t breathe (due to the lockdown).” American working people were just victimized by the biggest heist in world history, as trillions of dollars were transferred out of their

pockets and into the pockets of the world’s biggest banks, corporations, and billionaires, all on the pretext of the Covid-19 emergency. The thieves don’t want their victims to remember or even understand what happened. Telling people that they can’t breathe due to police brutality, rather than the financial brutality of a ruling elite that just dispossessed them, could be a deliberate propaganda strategy designed to deflect anger toward police—fellow working people—and away from the banksters and their hired guns, including public relations experts.

It is also noteworthy that the whole world is chanting “I can’t breathe” in the midst of a pandemic that kills people by preventing them from breathing. If you come down with flu-like symptoms, we are told, the first sign that you should head for the hospital is if you experience difficulty breathing. Those hardest hit by the virus actually turn blue; it seems that alongside the lung infection, they are suffering from cyanide-like symptoms involving damage to the oxygen-processing abilities of their red blood cells. So, putting the slogan “I can’t breathe” front and center in the world’s collective consciousness may tend to subliminally reinforce the mass panic over Covid-19.

This may sound odd to those who haven’t studied the history of propaganda and coercion. But it is exactly the sort of thing that Edward Bernays, the father of those dark arts, used to dabble in. For details, watch the excellent BBC documentary “The Power of Nightmares.”

So, the pandemic makes us feel like we can’t breathe. The lockdown makes us feel like we can’t breathe. The images of Floyd’s death make us feel like we can’t breathe. The image of rioters spreading mass violence, and soldiers in the streets meeting them with pepper spray, rubber bullets, and even live fire triggers an adrenaline reaction, and our breath is constricted into ever-shorter gasps. Meanwhile, the one place where



we used to be able to breathe freely and speak our minds—the internet—is being locked down under increasingly draconian censorship. Even the president of the United States is now being censored. When free speech is smothered, our national conversation dies of asphyxiation. And when conversation dies, violence roars in to fill the vacuum.

Maybe it’s time for us to pause, take a deep breath, and reflect on how we got to this place. Why did we let the banksters take over our country in 1913? Why did we let them orchestrate the world wars and drag America into them? Why did we let the banker-run CIA become the world’s biggest drug dealer? Why did we let them put the final bullet in the brain of our democracy on Nov. 22, 1963—and then seal the deal with the controlled demolition of the American republic on Sept. 11, 2001? And why did we let their agents take over the mainstream media and lie to us so gratuitously about so many of the most important issues, to the point that today we have good reason to doubt so much of what they tell us?

If we can’t breathe, it isn’t just because our police murder people using the chokeholds they were taught by Israeli thugs. The real reason we can’t breathe is much worse: We’re being smothered under an avalanche of propaganda lies, and our opportunities to breathe a word or two of truth are being systematically taken away. ★



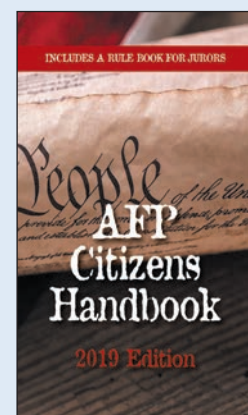

Rioting: An Unpleasant American Tradition

The president called out the military to handle the riotous protestors angered by what amounted to a battle of the entrenched and empowered versus the laboring class. America's largest urban centers were being destroyed, and New York City became the focal point of the battles for the streets. People were being lynched on the streets by gangs of vandals, looters, and thugs, and the number of wounded and dead could only be estimated. The damage totaled over \$3 million. That was 1863 money.

The New York City riots of 1863 were some of the costliest in history and it was President Abraham Lincoln who sent in the military to quell the angry rioters hell-bent on a revolution that would keep them from fighting against friends and relatives. A military draft had taken place, but it was, in essence, a draft of the poor. It was another rich man's war fought by the poorest among us. A loophole in the draft allowed a man to pay \$300 to avoid conscription (\$5,000 in today's dollars). Thus, a wealthier gentleman could avoid the fight by paying another to take his place. The bodies of the poor would line the battlefields of the Civil War on both sides.

One of the most famous riots in America occurred in the Los Angeles neighborhood of Watts in 1965. Watts had long been a low-income, minority neighborhood that had seen its residents fall victim to the stern police measures employed in poverty-stricken areas many times dominated by organized drug gangs. What began as a traffic stop to confront a drunk driver escalated into a six-day riot that cost 34 lives. It was the most dangerous case of civil unrest in Los Angeles to date, and it would remain so until the Rodney King riots of 1992.

On July 23, 1967, Detroit police raided an illegal speakeasy in one of the roughest areas of town. The police battered the inhabitants and word quickly spread to those in the neighborhood. It was excessive force, and the neighborhood quickly gathered on the streets. After a bottle was thrown through a police car window, over 400 patrolmen rushed to the scene. The protestors set fire to nearby buildings and threw rocks, bottles, and anything they could find on the ground. After five days of non-stop violence and protest, 43 people were dead and 342 injured, almost 1,400 buildings were burned, and the damage was estimated at upward of \$80 million. In addition, 7,000 National Guard and Army troops had been brought in to end the violence.

For those who lived through the 1990s, the LA riots of 1992 are the most memorable of their lifetimes. Four LAPD officers were caught on camera beating Rodney King in the first nationally viewed video of its kind, kicking off the "police the police" trend. On April 29, all four officers were acquitted of criminal charges for the obvious beating. Los Angeles erupted as the anger manifest itself through looting, violence, and arson. The National Guard was called in six days

later but, by the time the violence subsided, thousands had been injured and 53 killed during the riots, over 1,000 buildings had been destroyed, and the cost of the damage totaled over \$1 billion—the financially costliest civil unrest in U.S. history.

There are dangers to protest. In an 1884 riot in Cincinnati, 50 people were killed, an estimated 200 lives were lost in the 1914 Ludlow, Colo. coal mine riots, and 34 were killed at the 1943 Packard riots in Detroit.

Protests and riots are the foundation of American independence, and they are as old as the flag and the eagle. The 1770 Boston Massacre took place when Bostonians were outraged that Redcoats were taking their jobs at the docks, the 1773 Boston Tea Party did over \$1 million in damage in today's money, and the 1775 Stamp Act riots occurred when the colonists were taxed with-

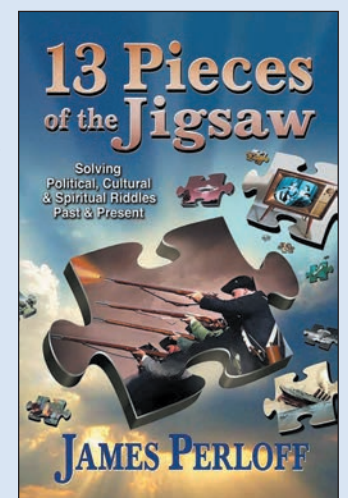
out their consent.

Rioting is as much a part of American history as free speech. When those in power refuse to accept and execute their responsibilities in ways that are just, peaceful, and equitable, those affected most by their tyranny rebel. As historian Heather Cox Richardson wrote, "American rioters take to the streets for a peculiarly American reason: They believe that the government is unduly privileging someone over them. The game, they think, has been rigged, and they are the losers." In the Declaration of Independence, Thomas Jefferson deemed rebellion an obligation. The 2020 riots may not be the costliest, and the lives lost will not make them the deadliest. The rush to attach historicity to them is a common fault of those living in the time, but it's a comparison only history can make. ★

The Real Issue They Should Protest

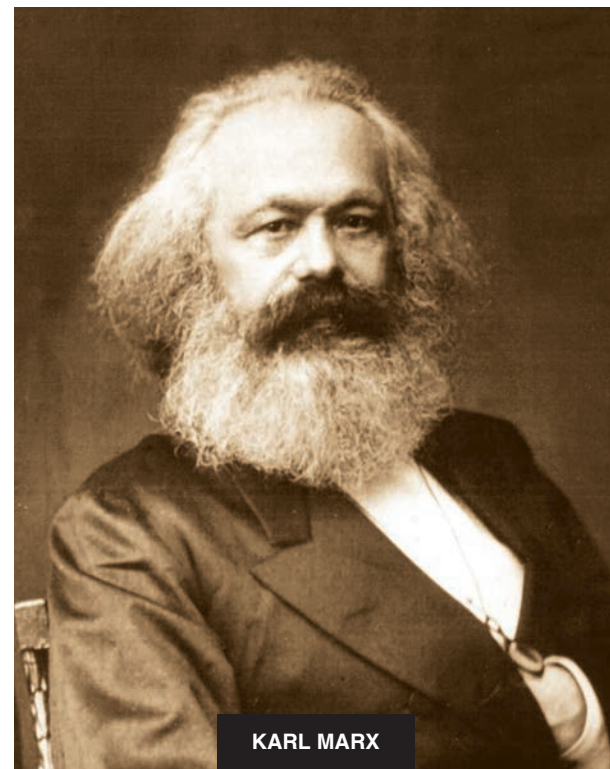

Majority white America has voted for a black president, votes for black politicians at all levels, wears the jerseys of black athletes in the millions, buys millions of dollars' worth of black artists' music, watches black films, lauds black thinkers, reads books and poetry written by black authors, observes black history month, employs African Americans, is employed by African Americans, worships side-by-side with minorities at churches, marries black and brown men and women, etc etc. Thus, we can honestly say that black America is adored by a huge percentage of white people. White Americans are even washing the feet of black Americans across the country as you read this. And let's not forget that 350,000 white Americans died in the U.S. Civil War to "free the slaves."

What they did not know was that the czar wasn't even in town. Worse, they had been set up. Left-

ists bent on creating a violent confrontation had swapped the list of grievances with demands for the czar to abdicate. Among the peaceful protesters were stationed agitators with guns and other weapons. They fired on the czar's Cossack guard. They instigated the action they desired. The czar's troops attacked and mowed many of them down for fear this now-violent mob—no longer seen as a group of peaceful protesters—would reach the palace and burn it to the ground or storm it and loot it. Riots and looting ensued across St. Petersburg. It was the beginning of the end for Christian Russia—and it has taken that nation over 100 years to recover.

One of the things Karl Marx learned during his life, however, was that class struggle was not the way to really incite the masses to violent revolution. Once a poor man escapes poverty, he is not really that interested in the revolution any more. Racial strife, Marx came to understand, was the way to really divide and conquer a nation and launch a revolution.

The other thing Marx knew was that schools and institutes of higher education were great places to brainwash large numbers of young people into his destructive ideology.

Does this all sound a bit too familiar? ★

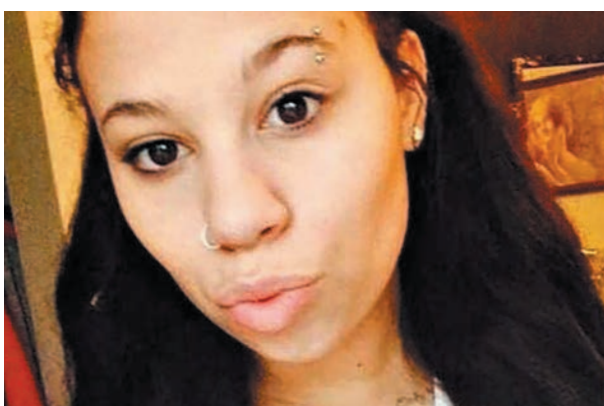

The Lootin' & the Lyin'

Nationwide multi-racial protests quickly devolved into widespread looting, vandalism, arson, and violence in the immediate aftermath of the killing of George Floyd, a 46-year-old black man with a lengthy criminal record, while being arrested by Minneapolis police on May 25. The sometimes violent demonstrations led to the destruction of entire neighborhoods, business districts, and other private and public property in cities across the country.

In recent weeks, the protests have spread to Europe and Australia, with protesters there defacing and toppling historic monuments and statues in a worldwide uprising against so-called “systemic racism” and “white privilege.”

In Minneapolis, protests in the days following Floyd's death degenerated into countless businesses being ransacked, looted, and destroyed. The city's Third Police Precinct, just a short distance from where Floyd was killed, was overrun and set on fire by a marauding mob after officers abandoned the building. Numerous other businesses in the city were entirely looted, and many were set ablaze afterwards.

The mayhem and madness spread across the country quickly, with rioting, looting, assaults, vandalism, arson, and widespread criminality being reported in virtually every major American city. In many instances, those participating did not even pretend to be concerned about the death of Floyd, and simply used the opportunity to steal, pillage, and destroy with impunity. While looting and violence has subsided over the

course of the past few weeks, organized protests led primarily by the Black Lives Matter movement have continued around the country.

Video footage of the rioting and looting has shocked the world. During the criminal mayhem, attacks against mainly white victims has been captured on video and shared on social media, as has the pillaging and looting of countless stores, many owned by minorities. Video images of largely black mobs looting stores and stealing virtually everything in sight were displayed on television and social media around the world, as law enforcement officers stood down, allowing them to ransack with impunity.

Local government officials and dishonest media pundits were quick to falsely blame whites for the looting and destruction, with some even going so far as to blame “white supremacists” for organizing the campaign of criminality.

Minneapolis Mayor Jacob Frey stated that “white supremacists, members of organized crime, out-of-state instigators, and possibly even foreign actors” were involved with organizing and participating in the looting and destruction of the city he governs, despite the endless video-graphic and photographic evidence of almost entirely black mobs doing the marauding. Minnesota Gov. Tim Waltz and the state's police commissioner John Harrington also suggested that “white supremacists” were behind the violence at protests and the subsequent looting when the mayhem first broke out, without providing any concrete evidence.

Seattle Mayor Jenny Durkan insisted that “much of the violence and destruction, both here in Seattle and across the country, has been instigated and perpetuated by white men.”



“These individuals experience the height of privilege and are co-opting the peaceful demonstrations that were organized by and meant to center people of color, particularly black Americans,” Durkan argued.

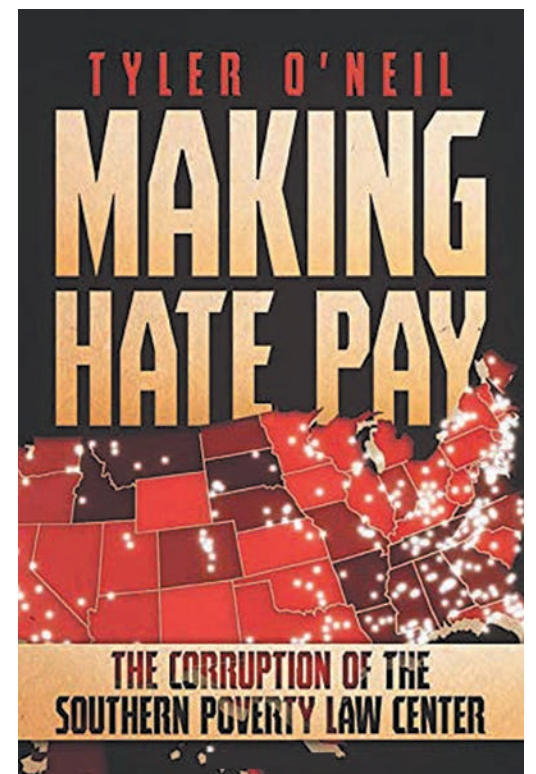
Not everyone is afraid to identify the true culprits behind the campaign of chaos and destruction in the wake of the death of Floyd. Jesse Lee Peterson, a black conservative pundit and radio host, recently argued that criminals are “using the protests as cover to loot” and that the “riots and looting have nothing to do with justice for George Floyd.”

“For decades, phony black ‘civil-rights leaders’ have been encouraging angry blacks to take the riots and looting to affluent white neighborhoods,” Peterson continued. “Now, Black Lives Matter, Antifa, and their radical leftist allies are doing just that. The riots are an organized attack on white-owned businesses and capitalism by thugs who hate America and President Trump. The problem is with black people, not whites. Blacks don’t need more programs or reparations. They need to examine their hearts and repent of their anger and hatred.” ★

Why We Have the Second Amendment

chaos,” he said. Outlaw added, “We strongly encourage if there is a non-violent way to protect one’s self or property, that should be the option.” In other words, abandon ship. Good thing Outlaw wasn’t in charge of the men at Lexington Green or Kenney wasn’t leading the troops at Guadalcanal.

In this case, the armed citizen in question was fully within his rights to not only protect his personal property and his own life, but also the lives of those peaceful people in his neighborhood.

In St. Louis, retired police Capt. David Dorn, an African-American, was shot dead while attempting to defend his friend’s pawn shop from looters. Dorn was said to have been a “gregarious and outspoken leader who mentored youths and insisted on strict ethical conduct among his employees.” He was described by policemen he worked with as the kind of person who would lay down his life to save a friend. That night he did just that. Unfortunately, this extraordinary man will no longer be around to mentor and guide the very kind of youths who shot him.

A bystander called 911, but also photographed Dorn as he lay dying, and posted it on the internet. At least he died with a gun in his hand while trying to stop pure evil. His was a life that mattered, whatever race he was. But you didn’t see any outrage from the Black Lives Matter crew nor

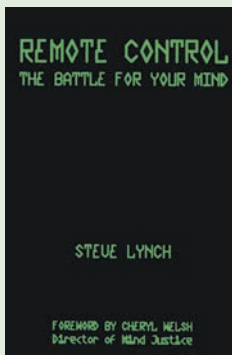
the neo-Bolshevik media. To them, Capt. Dorn was not the kind of black life that mattered, as he did not die at the hands of a cop or a white man. If it counters their race-baiting narrative, the event is ignored.

History is replete with examples of despots disarming the people. In every instance, as one would expect, law-abiding citizens were placed at the mercy of government thugs and dangerous criminals. Here in Virginia, Gov. Ralph Northam has made it quite clear he will do everything in his power to disarm citizens. Let’s hope he is not re-elected. Other politicians are actually discussing abolishing police departments.

But there are a few sane people in positions of power left in America. In Polk County, Fla., Sheriff Grady Judd is not infected with political correctness. He warned those looters who threatened to take their hooliganism into the suburbs to think twice. The citizens of Polk County, says Sheriff Judd, love guns, and if these would-be looters “value their lives,” they shouldn’t invade suburbia. “In Polk County . . . I encourage people to own guns, and they will be in their homes tonight, with their guns loaded.” In his warning to looters, he said, “If you break into their homes to steal, to set fires, I am highly recommending they blow you back out of their house with their guns. So leave the community alone.” There is a guy who understands the Second Amendment.

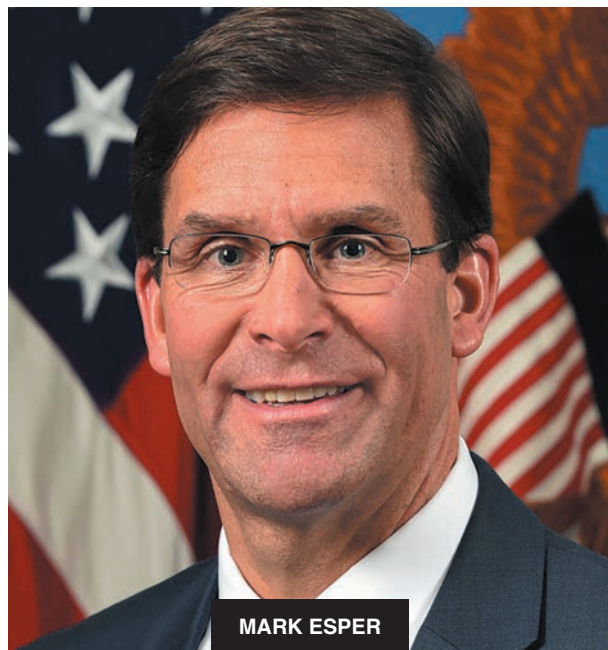

• Did an empowered White House go too far to restore “domestic tranquility”?

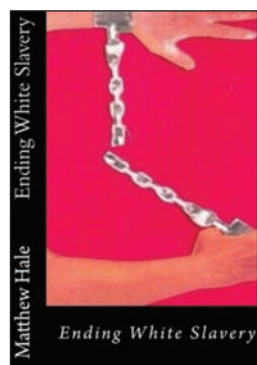
The government responses to the killing of black man George Floyd by white Minneapolis police officer Derek Chauvin and three other officers have produced the highest level of national unrest seen in the United States since the 1960s. Tens of thousands of protesters are demonstrating against institutionalized racism and perceived police brutality. As it also comes at a time of coronavirus pandemic and record unemployment, it has the potential to change the United States in fundamental ways. The core issue is that many on both the left and right see America’s police as something like an “occupying force,” increasingly self-serving enemies of the people rather than careful protectors of the taxpayers’ lives and property. What most demonstrators are failing to see, however, is that rather than moving in a more libertarian direction, the change coming to the United States might be a move toward expanding and strengthening the police state, a totalitarian response similar to the Italian and German responses to widespread left-wing street violence in the 1920s and 1930s.

History teaches us that changes in seemingly entrenched attitudes and beliefs occur regularly, though they can sometimes move as slowly as glaciers. When they move more quickly, they are called a “revolution.” In that context, it is interesting to note in a *Washington Post* story the insights of some American national security veterans who spent their lives studying authoritarian regimes. Most of the critics are admittedly hostile to President Donald Trump, but they are now seeing something like a possible rapid national slide into totalitarianism driven by fear and by how the protests are being addressed by government.

In the United States, law enforcement was traditionally seen as a function of civil society with

states having the back-up of the National Guard, which could be called out to confront serious civil unrest. That was generally how the major riots of the 1960s were handled, and there was little change in that formula until 9/11 took place. The fear that was perhaps deliberately stoked about the threat of terrorism led to a melding of civil and military, which led to “militarization” of the police, who were increasingly trained in military style aggressive tactics, to include the creation of SWAT (Special Weapon and Tactic) teams even in relatively small counties and towns. Cops also increasingly received special anti-terrorist training, to include a multi-layered relationship with the human rights-challenged Israeli police, an innovation promoted by Michael Chertoff when he was director of Homeland Security. Surplus military equipment soon followed on the training, with local police and sheriffs’ departments being gifted with armored cars, automatic weapons, body armor, and even some heavy arms capable of destroying a building. Tactics for confronting rather than protecting the public developed along the lines of the training and equipment.

A politicized and corrupted police force that becomes divorced from the public it is supposed to serve and that defers to the authority of government is one of the key elements in the movement toward totalitarianism, where the government has all the power and authority to behave as it sees fit. So, the police became the frontline agents of government control, but they really went over to the dark side after the passing of the Patriot Act and accompanying legislation, when local police forces adapted counter-insurgency methods to monitor Muslim and immigrant neighborhoods in a number of U.S. cities, most particularly in New York and New Jersey. In 2014, the New York Police Department’s revelation that it had deployed what it called “counter-terror” measures against Occupy Wall Street protesters encamped in downtown Manhattan’s Zuccotti

Park demonstrated that the writ of the War on Terror could be expanded to include criticism of American vulture capitalism.

To the former intelligence officers observing the scene in Washington, a disturbing cycle is clearly visible, with violent protests followed by crackdowns by police and military and assertions from government that its authority shall not be challenged. President Trump has called on the military and police to “dominate the streets.” It is not dissimilar to the reaction by the Chinese government at Tiananmen Square in 1989 or in Hong Kong currently and to similar government-ordered attacks on protesters in Turkey,

Iran, and Malaysia.

Perhaps more ominous is the warning coming from at least one CIA analyst quoted by the *Post* who observed, “I’ve seen this kind of violence. This is what autocrats do. This is what happens in countries before a collapse. It really does unnerve me.” Another former CIA operations officer also cited was particularly disturbed by the image of Donald Trump lifting a Bible while standing in front of the boarded up and fire damaged St. John’s Episcopal Church in Washington after tear-gassing protesters to make a symbolic short walk from the White House. It was an evocation of a holy war against the demonstrators, an abuse of

religious sentiment to support a purely political agenda.

Other administration high officials amplified the message coming from Trump, with Defense Secretary Mark T. Esper calling on state governors to “dominate the battlespace” with protesters, which many have interpreted to be a decision to treat some U.S. cities as foreign war zones. Chairman of the Joint Chiefs of Staff Gen. Mark A. Milley has also been sharply criticized for participating in the Trump church-front photo op wearing battle fatigues.

Foreign observers of the turmoil in the United States quickly noticed the essential hypocrisy in a White House that condemns China and Iran for their repressive tactics while also demanding “dominance” over American citizens, most—but not all—of whom have gathered peacefully to protest the actions of government.

After interviewing a number of current and former intelligence officers, the *Post* concluded that, if the British, Germans, Russians, and Chinese were currently writing intelligence assessments on the United States, which they certainly are doing, they would conclude that the country is in sharp decline both physically and morally. The inability to deal effectively with the coronavirus pandemic as well as the loss of confidence in the essential fairness of both government and the economy have made many Americans fear what kind of country might emerge from all the troubles. That the country could prove unable to deal with the internal contradictions might lead to itself changing dramatically, moving in either an anarchical or totalitarian direction. It is something that should not be ruled out. ★

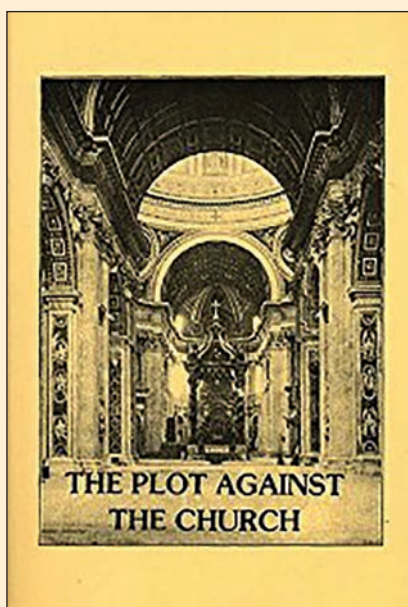

A History of the Original Rainbow Coalition

There was a time in American history when black, white and brown banded together to make life better for communities in need. This was so frightening to the power elite, they had to kill it.

In 1969, the Black Panthers hosted a national meeting in Oakland, Calif. They called it a “Conference for a United Front,” and it attracted activists from numerous radical groups across the country. Speakers at the conference included representatives from the Communist Party USA, the Farm Workers Union, Students for a Democratic Society, the Young Patriots Organization (YPO) and, of course, the Black Panthers.

The speaker from the YPO, William Fesperman, was an interesting fellow: He wore dark glasses, a military jacket, a beret and a belt buckle with crossed pistols and a Confederate battle flag. Both the jacket and the beret also had Confederate flag patches on them. Though a resident of Chicago, Fesperman spoke with a heavy, drawling Southern accent. The Young Patriots he represented were dislocated Southerners and Border Staters—many from coal country in West Virginia and Kentucky—who had migrated to Chicago to find work in the mills, only to end up unemployed and living in a northside ghetto commonly referred to by the city’s southside blacks and westside Hispanics as “Hillbilly Harlem.”

Fesperman and his YPO, along with Chicago’s southside Black Panthers, were among the founders of the city’s Rainbow Coalition, a name and an idea that Jesse Jackson would famously appropriate more than a decade later.

Before Jackson and the modern-day Democrats had determined upon the path of identity politics, the Rainbow Coalition was the embodiment of the idea that disfranchised people of all races, whether white, black, brown, red or

yellow, could work together to create a new society that would benefit every group—the exact opposite of the political model employed by the “Rainbow Coalition” and left-wing politicians of today.

In the 1970s through the 1980s, the Chicago this author grew up in was a very segregated city. Poor whites lived in the north suburbs, poor

blacks on the southside, and the browns—Hispanics—were found on the westside.

Over a decade after the federal courts had allegedly “desegregated” the Chicago public school system, the schools still remained segregated in practice. I attended an ostensibly “desegregated” elementary school that was still demonstrably segregated. This was achieved by assigning white teachers to teach white students, black teachers to instruct black kids, and Hispanic teachers were assigned to teach Latinos.

One day, when I was in either the first or second grade, a black kid transferred to our school in mid-year and was mistakenly assigned to a white classroom. By the next day, I was one of only a few white kids whose parents hadn’t pulled us from class. Eventually, the principal assured the parents that the black boy had been moved to an “appropriate” class.

Chicago’s neighborhoods were not just segregated by race, they were segregated by ethnicity, as well. In other words, the blacks divided into neighborhoods for Jamaicans, Africans, Creoles, Haitians etc. Likewise, the Hispanics were divided as Mexicans, Puerto Ricans, Cubans, Colombians, Peruvians, Brazilians, Hondurans etc.

Even the whites divided into neighborhoods for Poles, Italians, Frenchmen, Serbians, Gypsies, Germans, Greeks, Brits, “hillbillies” etc.

An Italian would probably sooner have a black family move into the neighborhood than a Polish one. The same was true of other races as well. For example, the Mexicans and the Puerto Ricans never mixed.

“Hillbilly Harlem” was actually a slum, densely populated with poor whites who had migrated north after WWII, primarily from Appalachia. Their neighborhood had a culture that

was very different from that of the other whites in Chicago because they displayed Confederate battle flags in their taverns, and country music spilled out of their jukeboxes.

Hy Thurman and his older brother Rex grew up in Dayton, Tenn. In 1967, they dropped out of high school and hitchhiked to Chicago to find jobs. When they couldn't find them, they sold their blood to blood banks for cash. Eventually, they found work as day laborers.

They also joined a street gang called the Goodfellows, which soon joined forces with a community organization having the acronym “JOIN” (Jobs or Income Now) that demonstrated for housing and welfare reform by fighting Mayor Richard Daley's political machine and the Chicago police.

Organizing against police brutality was a top priority for the Goodfellows because their members were constantly stopped by police and subjected to unlawful searches and sometimes even beatings. One day, the police raided JOIN's office that was located in a church sym-

pathetic to their efforts. A police officer shot an unarmed Goodfellow in the back as he was running away.

This senseless act of murder by Chicago's “finest” was the catalyst for the Goodfellows, JOIN, and other groups of “hillbillies” to join forces and organize into what came to be known as the YPO. The YPO proudly proclaimed itself to be “by and for hillbillies.” The group was very organized. They were formally constituted, elected leaders, drafted an 11-point program and adopted the Confederate battle flag as their official symbol.

The Thurman brothers recruited new members from among all of Hillbilly Harlem's pool halls, taverns and honky-tonks. In his recruiting efforts, Thurman encountered Bob Lee of the Illinois Black Panther Party, who quickly realized that he and Thurman—though working in different sides of town and among different races—were essentially fighting the same foe

and doing so with similar tactics.

Thus, in the fall of 1968, Lee invited Thurman to join him to address a mostly white Methodist church where Lee was scheduled to speak to a group of white, middle-class liberals who were curious about the non-militant side of the Panthers. At Lee's request, Thurman also gave a presentation on the efforts of the YPO.

While the audience treated the black Lee as a curiosity, they were openly hostile to the white Thurman. (Recall how I earlier remarked that a white in Chicago would prefer to have a black move into his neighborhood than another white of the wrong ethnicity?) The liberal middle-class whites were far more tolerant of Lee's Black Panthers than they were of Thurman and his hillbilly patriot group.

Lee could not believe what he saw and heard. He watched middle-class whites attack poor whites with a brutality that even the ethnically and economically segregated blacks would have never let loose upon one another. Lee rose to Thurman's defense at the meeting, and afterward suggested that the two groups join forces.

Initially, Fred Hampton, the chairman of the Illinois Black Panthers, expressed strong op-

position when Lee formally proposed the unification at a Panther meeting. But after a few weeks of observing Thurman and the YPO, Hampton and the rest of the Panther leadership became enthusiastic about the merger.

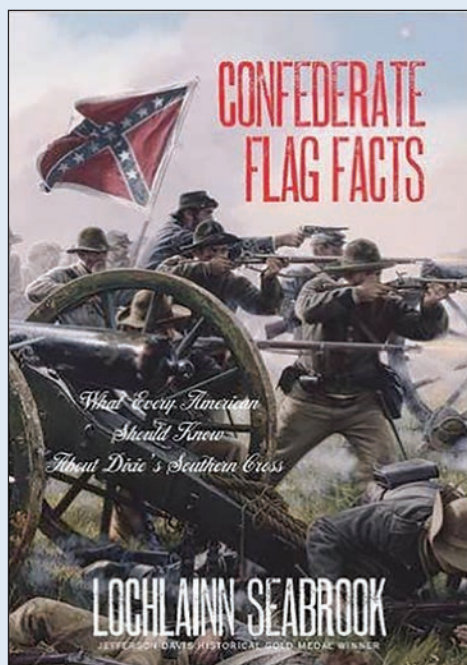
It was then that they christened their alliance "the Rainbow Coalition." The Panthers even voted to adopt the YPO's symbol—the Confederate battle flag—after merging it with their black fist symbol. The YPO had never considered the battle flag—or as they called it, "the Rebel flag"—as a symbol of racism. They called it "the Rebel flag" because they saw it as a symbol of rebellion. The Panthers thought of "the Rebel flag" in exactly the same way.

Under the banner of the Rebel flag, the Rainbow Coalition grew to include the Young Lords, a radical Puerto Rican group. Together, the blacks, whites and browns held citywide unity rallies speaking out for police reform and against poverty. They held rallies in places like Grant Park and occupied government buildings to demand better health care and housing.

Gang members from all races were drawn to the coalition. They eventually organized their own neighborhood clinics and social services. Even the American Indian communities began to join them, and they started a free breakfast program. Then the middle-class whites started

to join groups dedicated to helping the poor.

When that happened, Mayor Daley began to see the coalition as a rival to his political machine. He had the police shut down the free breakfast program and ordered the health department to close their neighborhood health clinics. The FBI also infiltrated the group and immediately began to sow seeds of discord that would tear apart the interracial coalition.

Just five months after their big meeting in Oakland—on Dec. 4, 1969—the Chicago police conducted a pre-dawn raid of Fred Hampton's home and, in the process, murdered the leader of the Panthers. This sent Thurman and other coalition leaders into hiding.

Fesperman broke away from the coalition, moved to New York and formed a political party he called the Patriot Party. After he established offices up and down the East Coast, the feds raided his New York office and other offices, effectively ending the enterprise.

Shortly thereafter, the Chicago police chief accused the YPO of conspiring to detonate a bomb and arrested much of its leadership. They even arrested people from allied churches and community groups as co-conspirators.

Still, the Rainbow Coalition persevered, eventually defeating the Daley political machine in 1983 when they succeeded in electing Harold Washington as the city's first black mayor.

Jesse Jackson declared himself the leader of the Rainbow Coalition in 1984, using it to launch his insurgent presidential campaign. He would ride the coalition wave all the way through his nearly successful 1988 run.

David Axelrod, who would later serve as chief of staff to Barack Obama, drew on what he learned as a Rainbow Coalition activist when he managed Mayor Washington's 1987 reelection campaign. He would retool the same tactics in 2008 to maneuver Obama into the Oval Office, though many insist Obama was ineligible.

But as modern Democrats like Jackson, Axelrod and Obama (the "community organizer") took over the Rainbow Coalition—even using its strategy and methods—they discarded the coalition's appeals to racial unity and class solidarity, replacing them with rigid racial identity politics. And, of course, they tossed aside the banner under which all of the races had united in the original coalition: the Confederate battle flag. ★

Israel's Militaristic Influence on America's Police Forces

The arrest technique of using knee pressure on a suspect's neck, seen specifically in the arrest and death of George Floyd in Minneapolis, is nothing new in policing. It is one of many tactics the Israeli military has been teaching our police forces.

The technique has the potential to be lethal because excess pressure on the neck can damage the small bones and arteries in that part of the body which carry oxygen and blood to the brain. It also cuts off oxygen when the knee is applied to the carotid artery. Online there are many photos of Israeli soldiers using this submission technique against young and old, male and female Palestinians.

Police officers across this nation are entitled to ask why they have never been properly instructed about the dangers of the technique and its origins. One answer is that a lot of police chiefs have been happy to see it deployed, having visited Israel and learned that it is an effective arrest method frequently used in the West Bank.

The role of Israel in training our police chiefs and officers how to use Israeli riot control methods is one of those issues that has attracted little attention from the mainstream media. For example, in 2018, when three police forces in Vermont, Massachusetts, and North Carolina sud-

denly ended police trips to Israel for training sessions, the matter went unnoticed elsewhere. The decisions by those forces followed pressure from local groups that pointed out how the Israeli military's policing methods crossed many human rights lines and were not an example to be followed in the United States.

Minnesota, now at the center of the news following the death of Floyd, sent over 100 of its police officers for training to Israel in 2012. There are no figures available for the numbers of policemen from all states that were trained in Israel since that period, though it is known that the training has included personnel from ICE, the FBI, and the U.S. Border Patrol.

One of the problems of relying on Israeli riot-control and crowd-control tactics is that Israel links policing with counterterrorism. In their riot-control efforts, they often use live fire and have killed many teenagers, women, and children. Their systemic abuse of Palestinian civilians has been well documented. Senior figures in Israeli intelligence agencies, particularly the Shin Bet, like to link ordinary crime and terror as though they were the same phenomenon. Israel's philosophy is the total domination of crowd protests with the use of overwhelming force. It is language with which we are now familiar here in the States. Israel exports every security technique it uses against the Palestinians.

During the "Troubles in Ireland" (the 30-year conflict between Irish Catholic nationalists and British Protestants, the British army shared its knowledge with police forces worldwide because its troops perfected the use of rubber bullets, which were larger than the ones used recently in Washington and other cities. The British rubber bullets had a lethality that eventually led to their discontinued use. The British army also invented the deployment of snatch squads, a technique the Israelis subsequently adopted. These are squads of heavily built soldiers armed with batons who are sent into riot situations to seize rioters identified as ringleaders.

But it is Israel's military that is the go-to force for U.S. police chiefs. In 2017, over 52 senior police officers visited Israel for training as part of what had been an annual Police Unity Tour, starting in 1997. Few people know that since 2012, the New York Police Department (NYPD) has had its own facility within the Israeli police coastal headquarters at Kfar Saba.



Are those policemen in America who are being trained in Israel treating those they arrest more like prisoners of war? The infamous knee-to-the-neck restraint technique is one used frequently by Israeli police and military against Palestinians.

Many of the police trips have involved training conferences with the leaders and units of the Yasam, a highly controversial Israeli elite police force known for its mistreatment of Palestinians. Little mention has been made of the fact that the training of U.S. security personnel was financed by the Anti-Defamation League (ADL). It is a strange arrangement since the ADL is not a police body and should have no role in directing the training of American police. The ADL argues, however, that it is merely bringing together friendly forces with a common goal of dealing with social issues. It has not defined the common goal or how the Palestinian situation compares to policing objectives in U.S. cities. The arrangement has enabled Israeli security corporations to market riot-control weapons to police forces and other security agencies in the U.S., but according to "RevealNews," the multi-platform news arm of The Center for Investigative Reporting based in San Francisco, tear gas grenades, triple-chaser gas canisters, and stun grenades made by the American companies Combined Systems, Inc. and Defense Technology Corp. have been used in Israel and in recent street events in America.

For those police officers charged with killing George Floyd, the question of who approved the technique they used to arrest and subdue him should be an easy one to answer. Police chiefs have long adopted and approved of the technique, having imported it from Israel, a fact ignored in recent cable media coverage of events. ★

Official Busted for Bilderberg Trip

On June 5, Colorado's Independent Ethics Commission (IEC) unanimously found former Gov. John Hickenlooper (D) in violation of state ethical standards by accepting prohibited gifts and perks while attending the 2018 Bilderberg Meeting in Turin, Italy. This marks a historic judgment against an American elected official for attending Bilderberg's highly secretive annual confab. It is now the time of year that Bilderberg would normally meet but isn't doing so due to their alleged fear of Covid-19. What's more, the IEC voted unanimously on June 4 to find Hickenlooper in contempt of IEC proceedings for not showing up in violation of a subpoena to participate in that day's hearing.

The two days of IEC hearings concerning Hickenlooper—which involved about 14 hours of scouring the details from his travels in 2018—were held online due to Covid-19, and this writer attended via an online meeting platform. The original complaint about Hickenlooper's trips was filed with the IEC in mid-2019 by former State House Speaker Frank McNulty (R). Suzanne Staiert served as McNulty's legal representative at the hearings, while Hickenlooper was defended by attorney Mark Grueskin.

Hickenlooper's attendance at Bilderberg 2018 was his first-ever at the globally unique gathering of the rich and powerful from the public and private sectors. And it appears he was the only U.S. elected official at that particular meeting, which was hosted by Fiat-Chrysler. The IEC panel did not believe Hickenlooper's vague recollection under oath that the \$1,500 he paid with his personal funds upon checkout from the hotel where Bilderberg met in Italy, covered not only the hotel but also several catered meals, cocktail hours, transportation in a Maserati limo, two field trips, and other perks and amenities. What's more, the IEC noted that Hickenlooper's attendance at Bilderberg did not serve the state's interest under Amendment 41 of the state constitution, which voters approved in 2006 to create the IEC and reign in mischief by public officials.

Asked why he attended Bilderberg, Hickenlooper said the Bilderberg Steering Committee had him speak in panel discussions regarding Colorado's "economic program," which the Bilderberg group evidently looks upon favorably.

Asked if he examined the official Bilderberg website upon being invited, Hickenlooper replied, "No," though he said he looked at a confidential



agenda that he had received. "The invitation was sent directly to me," he said, suggesting it did not go through his staff as was customary.

When asked if he knew in advance that Fiat-Chrysler was the host of the Bilderberg conference, he said, "I was not aware of that," nor could he remember whether he spoke to any Fiat-Chrysler representatives. And when Hickenlooper was shown a picture of him and former CIA Director David Petraeus talking with each other outdoors during the Bilderberg conference, Hickenlooper claimed not to recall what they talked about, while acting as if he could barely remember encountering Petraeus at all.

Momentarily mentioning the intrigue and "op-

tics" of Bilderberg, Ms. Staiert also queried Hickenlooper on whether he knew in advance that Bilderberg was "the Super Bowl of corporate lobbying." Hickenlooper coyly replied, "No. I understood it included a lot of senior executives."

Interestingly, the hearings placed considerable emphasis on Hickenlooper's attendance at Bilderberg even though it is one of five trips that has been under scrutiny. As AFP has previously reported, these proceedings bring fresh attention to Bilderberg, coming from an angle that Bilderberg's organizers would certainly prefer to avoid since the mainstream press has picked up on the story. That's a sharp departure from the usual situation where, if Bilderberg is mentioned at all in the controlled corporate press, it's done on a short-term basis and in muted, murky tones.

Amusingly, *The Washington Post* somehow managed to write an entire article on the IEC's findings without mentioning Bilderberg, while pitching the story mainly as a political fumble for Hickenlooper since he recently threw his hat in the ring to seek the Democrat nomination to take on GOP Sen. Cory Gardner. The *Post* is circumspect on reporting on Bilderberg, of course, because, typically, the newspaper sends its writers, editors or company representatives to the confab and, in so doing, agrees to keep its readers in the dark—a media practice at Bilderberg which goes back decades. ★

Biden's VP Search Just Got More Complicated

As Joe Biden quietly passed the number of delegates needed for the Democratic nomination for president, he reiterated two talking points from the campaign: He is going to choose a woman to run with him as vice president, and Michelle Obama is one of the women in the running. While Georgia's Stacey Abrams and Obama are both vocal admirers of Biden's campaign, and thus possibilities as running mates, most of the media attention has focused on the more pragmatic options, Sen. Elizabeth Warren and Sen. Kamala Harris.

Warren and Harris are both alpha personalities, women who strongly positioned themselves for their rise in politics. Senators from their respective states of Massachusetts and California, each has a built-in following in an important Democratic stronghold. The drawbacks for both as candidates are different, yet numerous and important in nature.

To step more in line with Biden's view on health care, Sen. Warren, speaking at the University of Chicago's Institute of Politics, affirmed a position that focused on an expansion of the Affordable Care Act (Obamacare) rather than doubling down on her previous support for a single-payer Medicare for All plan. This shouldn't be news to casual observers of Warren's life in politics. She has crafted a chameleon-like nature that will do anything, say anything, and be anything that will get her the public support she needs to advance. It has worked for her, but it's that shape-shifting nature that has also made her problematic.

Warren has professed, when politically valuable, that her kids attended public schools, that she was fired from a teaching job for being "visibly pregnant," and that she was of Native American heritage, a claim that earned her the name

"Lieawatha" from right-wing talk show hosts. Warren has a serious problem with the truth, a problem most damaging because her strongest untruths have dealt with her own biographical information. If Warren doesn't know who she is, it's safe to say America won't, either. When opposition research hits full stride, every detail of her life will be up for debate, as it should be. She also has likability issues with the national Democratic base, as J.T. Young explained at "TheHill.com" website.

"There is a reason why Warren did so poorly among her ideological soulmates," Young wrote. "People do not like her. Even when they agree with her, they find her disagreeable. As irascible as [Bernie] Sanders is, the left still prefers him overwhelmingly to Warren."

Sen. Harris is a different political animal. Rising through the ranks of California politics as part of the political machine of former San Francisco Mayor Willie Brown (with whom she had a personal relationship), Harris became the attorney general of California in 2011 before becoming a U.S. senator in 2017. Though Harris has spent her career in California (born in Oakland), she has operated as more of a Clintonesque Southern Democrat regarding issues of law and order. Harris has been tough on crime throughout her years in law enforcement, championing three-strikes-and-you're-out legislation, longer prison sentences, supporting a harsh war on drugs, punishing parents whose children skipped school, acting slowly to release African-American men falsely accused and exonerated by DNA evidence, and refusing to reconsider the case of Sirhan Sirhan, who has been imprisoned as the alleged assassin of Robert F. Kennedy for over 50 years, though there is evidence to indicate he did not act alone and may, in fact, have been brainwashed.

Harris dropped out of the presidential race in December, but she has maintained a few aides to operate her political organization. While Stacey Abrams has openly campaigned for the position

of vice president, and while Warren has surrogates doing very public campaigning for her, Harris has shied away from the spotlight and the questions. At a time when American streets are on fire with racial tension, Harris may be the wrong choice for a Biden campaign. As someone who locked up more African-Americans than nearly any attorney general in the country, it's a prosecutorial record that will be hard to defend in racially insecure times.

It's possible that Michelle Obama is a red herring that's being used to distract analysts from the glaring faults of Warren and Harris as potential running mates. "What you want in a running mate is someone who will bring assets to the ticket without a lot of liabilities," said California Democratic consultant Garry South. If that is the case, Warren and Harris both seem like abysmal options. ★

Biden Has a Serious Race Problem

As American cities continue to face protests over the police killing of George Floyd, predictions abound that the end of the Trump presidency is nigh. A change is going to come, the prognosticators say, and that change will be in the person of Joe Biden. If Biden is to be the great healer of the racial divide, however, it would be wise to look at Biden's own significant statements on race.

In the 1970s, Biden was asked about the legacy of slavery. He responded, "I don't feel responsible for the sins of my father and grandfather. I feel responsible for what the situation is today, for the sins of my own generation, and I'll be damned if I feel responsible to pay for what happened 300 years ago."

At the Sept. 12, 2019 Democratic debate, he was asked to clarify his statement. Biden launched into a confusing series of sentence fragments and changes of focus that mentioned but did not explain redlining banks, tripling the amount of money to poor Title I schools, raising salaries for teachers, bringing in social workers to deal with bad parenting (an oft-repeated placement of blame many parents are tired of hearing), and notably, playing their record player at night. Even pro-Democrat analysts were amazed at the bizarre nature of Biden's answer.

"Is this not one of the most explicitly racist moments of all time in a Democratic primary debate?" author Anand Giridharadas questioned. "Asked about his past comments denying responsibility, as a white man, for America's sins, he gives an answer insinuating that black parents don't know how to raise kids."

This wasn't Biden's only modern racial gaffe. In 2007, as he was about to announce his run for the presidency, Biden was asked about national newcomer Sen. Barack Obama. Biden's description of Obama has now become legendary. "I mean, you got the first mainstream African-American who is articulate and bright and clean and a nice-looking guy," Biden said. "I mean, that's a storybook,

man." What exactly Biden meant by "clean" is something he never explained, but his amazement that an African-American candidate could be articulate and bright was jaw-dropping. He tried to pass it off as a traditional remark, stating his mother had a saying, "clean as a whistle, sharp as a tack," but the damage was done. Because political tickets are commonly about filling deficient holes, Biden was later named the vice-presidential candidate on the ticket.

In a recent interview with black radio show host Lenard Larry McKelvey, who goes by the name of "Charlemagne tha God," Biden said, "Well, I tell you what, if you have a problem figuring out whether you're for me or Trump, then you ain't black."

David A. Love of CNN wrote about the conundrum Democrats find themselves in with Biden racially. "Depending on whom you ask, either Biden made an offensive remark, he spoke in jest and the joke bombed in its delivery, or he spoke

the truth—and Biden should be left alone, because criticizing him will only help re-elect President Donald Trump, they say. It's all so complicated—just like the history of race in the United States."

There were some who blatantly and inexcusably just pardoned Biden's comments as mere gaffes. Richard Fowler wrote for Fox News that Biden's "You ain't black" statement was "a rhetorical slip." Fowler continued, "Yes, Biden has made several missteps in his choice of words and his past policy positions, but the past three months of Trump's incompetent mishandling of the coronavirus crisis will carry more weight in voters' minds than Biden's fumbled choice of words."

At this point, it may be pointless to ask Democratic voters to consider their candidate's history, record, or obvious problems. He isn't Trump, and that's all that matters at this point. Yet, when voters experience buyer's remorse, it stings worse than expected. Biden, if elected, has the potential to be one of the most underwhelming presidents of modern times, if his health even allows him to complete a term.

When Charlemagne asked Biden why the black community should support his candidacy aside from being a protest vote against Trump, Biden quipped, "Take a look at my record, man!" That's a valid request. Consider it done. ★

Doctors Say End Lockdowns

Six hundred physicians recently signed a letter to President Donald Trump calling for an end to the coronavirus lockdowns. The physicians wrote that, far from protecting public health, the lockdowns are causing “exponentially growing negative health consequences” for millions.

Since the lockdowns began, there have been increases in alcoholism, drug abuse, and domestic violence. There has also been an increase in calls to suicide hotlines. This is a direct result of the mass unemployment and limitations on people's activities resulting from the lockdowns. As long as millions of Americans are sitting at home wondering how to survive until the government says they can go back to work, there will be more substance abuse and suicides.

At the start of the lockdowns, Americans were told to stay away from emergency rooms and doctors' offices to avoid exposure to coronavirus. This has led Americans to neglect their health. U.S. hospitals have seen a 40% decline in the number of patients admitted for severe heart attacks since March. Does anyone believe that the coronavirus panic just happened to coincide

with a miraculous decline in heart attacks? Physicians have also become unable to help many stroke victims who bypassed medical assistance.

Early in the coronavirus panic, hospitals were told to cancel elective procedures to ensure space was available. But hospitals were not overwhelmed by coronavirus patients.

According to the American Hospital Association, this has cost healthcare providers tens of billions of dollars in lost revenue. Inner-city and rural hospitals that already operate on slim profit margins are especially hard hit by the financial impact of the lockdowns. These hospitals may have to cut back on services. Some may even close. This will make it even more difficult for rural and inner-city Americans to obtain quality, affordable healthcare.

Postponing needed surgeries will have serious consequences. Many patients whose surgeries have been delayed will find that their once easily treatable conditions now require intensive and expensive care.

Some people are forgoing disease management and checkups that could keep them from developing more serious problems. The coronavirus lockdowns have even caused the canceling of chemotherapy treatments.

According to the physicians' letter to Trump,



the coronavirus lockdowns are preventing 150,000 Americans a month from finding out they have cancer. Skipped routine cancer screenings mean cancer is not detected in an early stage, when it is most easily treated.

The coronavirus lockdowns have upended the lives of Americans to “protect” them from a virus with a 0.2% fatality rate, with the majority of those fatalities occurring in nursing homes and among people with chronic health conditions.* Instead, the rational response would be to protect the vulnerable, and let the rest of the people live their lives. But politicians and government-anointed “experts” do not respond rationally to a “crisis,” especially when a panicked reaction can increase their power and prestige.

The lesson of the unnecessary lockdowns is clear: Government bureaucrats and politicians, even the media's beloved Dr. Fauci, must be stripped of the ability to infringe on our liberty and prosperity. ★

* Until adequate and affordable testing comes online in the U.S., it is impossible to know the exact mortality rate for young and old alike or for the healthy or the sick. For the elderly, the survival rate is estimated currently to be 75% to 80% for anyone above the age of 70 years.

A Prime Concern: Rescuing the Meat Industry

On Capitol Hill, a languishing piece of legislation known as the PRIME Act—H.R. 2859, the Processing Revival and Intrastate Meat Exemption Act, now sitting in the House Subcommittee on Livestock and Foreign Agriculture—may be getting a new lease on life. If signed into law and implemented, this legislation could put an end to meat shortages in the grocery stores tied to the coronavirus response while improving the quality of meat and shortening supply chains in the process.

According to the Texas-based Farm and Ranch Freedom Alliance (FARFA), Americans need to place calls to Washington (202-224-3121 or 225-3121) to give the PRIME Act the best possible chance of becoming law. FARFA explains: “Current federal law requires farmers who raise and sell livestock to use either a USDA-inspected slaughterhouse facility or a state-inspected facility that meets the USDA standards. The USDA regulations are very expensive and geared towards large-scale operations, which is why we have so few small federal or state-inspected slaughterhouses. Lack of inspected slaughterhouses is one of the biggest barriers for small-scale livestock producers. The lack of reasonable access to a slaughterhouse keeps some farmers from selling their meat at all.”

“Our best shot right now is in the Senate, which is still considering what to include in the next Covid relief bill,” a June 3 FARFA news release noted, while adding that calls to the House would be helpful, too.

First introduced by Rep. Thomas Massie (R-Ky) in 2014 and reintroduced again in 2019 as H.R. 2859, now with 47 cosponsors, the bill would amend the Federal Meat Inspection Act to clear the way for expanding markets for small “custom” slaughterhouses.

“There is a much greater chance of this passing now,” FARFA Executive Director Judith McGeary told AFP June 5. “We have possibly several million animals now being killed off and wasted because of the consolidation of the [meat] industry. Now there’s an awakening about the big meat packers,” she said, referring to the way such packers have consolidated control over the industry.

McGeary continued: “The need to diversify and re-localize our meat supply is something advo-



cates have been talking about for two decades. Advocates like myself predicted a crisis like this. . . . We knew this would happen. The PRIME Act [is] an important piece of fixing the system.”

While some small farmers are going months without income, consumers are seeing meat prices skyrocket. At the same time, custom slaughterhouses already operate safely in every state. But the core problem is that their market is limited. The meat processed in those facilities under current laws cannot be sold in conventional local market outlets.

FARFA summarized:

The PRIME Act opens up options for small livestock farms and ranches by removing the federal ban on the sale of meat from custom slaughterhouses within a state. These small-scale processors will remain subject to the basic federal regulations that already apply to them, as well as any additional provisions imposed by the states. At a time when we see empty grocery store shelves [of certain products] . . . this bill provides vital opportunities, and many long-term benefits. . . . The PRIME Act supports local food production and small busi-

nesses, while also reducing vehicle miles traveled with livestock trailers, and helping to meet the consumer demand for locally raised meat.

FARFA’s outlook matches that of “R-Calf USA” cattle industry spokesmen Shad Sullivan of Texas, and Bill Bullard of Montana, both of whom have spoken with AFP on the meat shortages in common retail outlets.

Bullard, who’s R-Calf USA’s CEO, corroborated Sullivan’s data when he told AFP that over 700,000 U.S. cattle producers are dependent on the meat-packing plants of only four monopolistic meat-packing companies: Tyson, JBS, Cargill, and Marfrig (which bought out the National Beef Packing Company).

Since those four companies and the limited number of packing plants they own are the only available sales avenues when it comes to ranchers processing their harvest, a bottleneck is inevitable when a shutdown or slowdown comes along, regardless of the cause.

“Only now is America waking up to the fact that, for many decades, we’ve ignored the national food security interests of Americans; we displaced what used to be a family-farm system of agriculture that had millions of dis-aggregated producers. You had tens of thousands more feed lots for the cattle industry, and you had hundreds more meat packers scattered all across the United States. That was inherently a robust and resilient system that would not be subject to a crisis like we’re dealing with today, because there were more, smaller processing facilities,” Bullard explained to AFP. ★

Was Woman Who Predicted JFK's Murder Killed for What She Knew?

***Rose Cherami: Gathering Fallen Petals*, by Dr. Michael Marcades with Norma Kirkpatrick**

Imagine you never really knew your mother, that when you were barely old enough to know who she was, she left you with your grandparents to raise, and that she died while you were still a young boy. Growing up, you heard bits and pieces of information about her. Vague comments, rich with subtext but poverty-stricken in detail. “Whispers” about “mysterious absences” and “hints that she was an unsettled soul who chose the wrong role in life.”

Wouldn't you want to know more, to find the missing pieces and fit them together to fill out a complete picture of the woman who gave you life?

Now imagine that, as a grown man, you devote yourself to uncovering the mystery that was your mother. To find the missing pieces—to discover who she was, to better understand who you are and where you came from. But what if those additional pieces paint a far darker picture than you ever imagined? Drug mule. Addict. Prostitute. Thief. Insane. You don't even know what name to call her, as she went by so many, starting with her birth name of Melba Christine—“Crit” for short—and ending with Rose. Rose Cherami. The name she bore as she lay dying on an east Texas highway.

So, what do you do? Do you stop digging, delete the bad, and try to just remember the good? Or do you continue to search? To find the truth. But will the truth really set you free? Or will it chain you to a sordid past, even if it's not your own?

That's the dilemma Dr. Michael Marcades faced

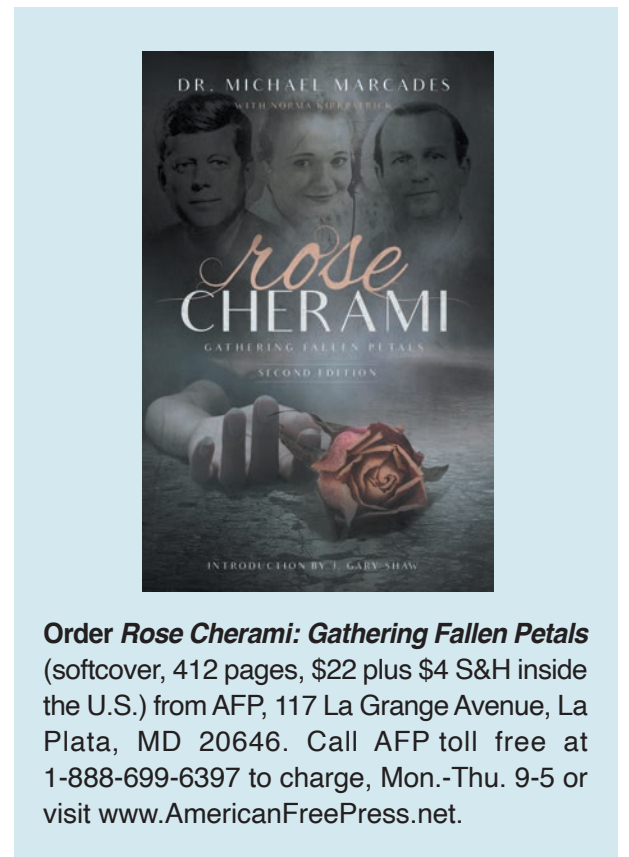
as he began his journey to learn about his mother's tragic life. The picture that emerged was both devastating and fascinating at the same time. And it placed his mother squarely in the middle of one of this country's greatest crimes: the assassination of President John F. Kennedy.

In *Rose Cherami: Gathering Fallen Petals*, Marcades gathers, and then snaps into place, the pieces of a misspent life by the woman he only vaguely knew as his mother. A woman who, just prior to President John Kennedy's visit to Dallas on Nov. 22, 1963, announced to a Louisiana State Police officer that men she had been traveling with—men who, like she, worked for Dallas nightclub owner Jack Ruby—were going to “kill Kennedy when he comes to Dallas.” Did that explosive secret lead to her death less than two years later? Your guess is as good as any.

Now the plot thickens. It's a conspiracy theorist's dream, but it begs the question: What if it's not just a theory; what if it's real? And how does that play into Rose's own tragic and mysterious death, on that lonely east Texas highway less than two years later? Accident? Or murder?

Written in the style of a novel, mixing in fiction to fill missing gaps in a meticulously researched record of fact, *Rose Cherami: Gathering Fallen Petals* tells the story of an imperfect woman as narrated by a loving son. The facts of Rose's life surely must have been painful to uncover, but Marcades ensures that her story is, in fact, told, with all her secrets laid bare, and that she is not just a footnote to a piece of history. Rather, she is a living, breathing contradiction who, like the rest of us, is neither all bad nor all good.

Though Rose's journey may have started with promise, it took a wrong turn somewhere and ended in tragedy. But no life is totally wasted. Marcades is Rose's living legacy. He is the proof that she passed through this world and left something good behind. “I know, in the eyes of many,

she was a woman of questionable character who lived a bizarre life,” he says. “Nevertheless, she gave me life, and in spite of her absence, or perhaps because of her absence, I have done my best to live it well.”

Marcades then concludes this about his own journey of self-discovery through discovering his mother's tragic journey: “Though I can't return to the past, or change it in any way, it brings me some degree of peace to have shared the experiences of my life with others who perhaps are looking for the same peace and acceptance within their own ambivalent lives.”

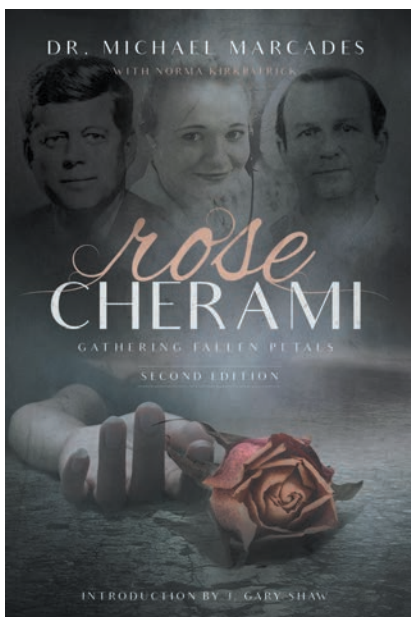
And that's a journey worth taking. ★

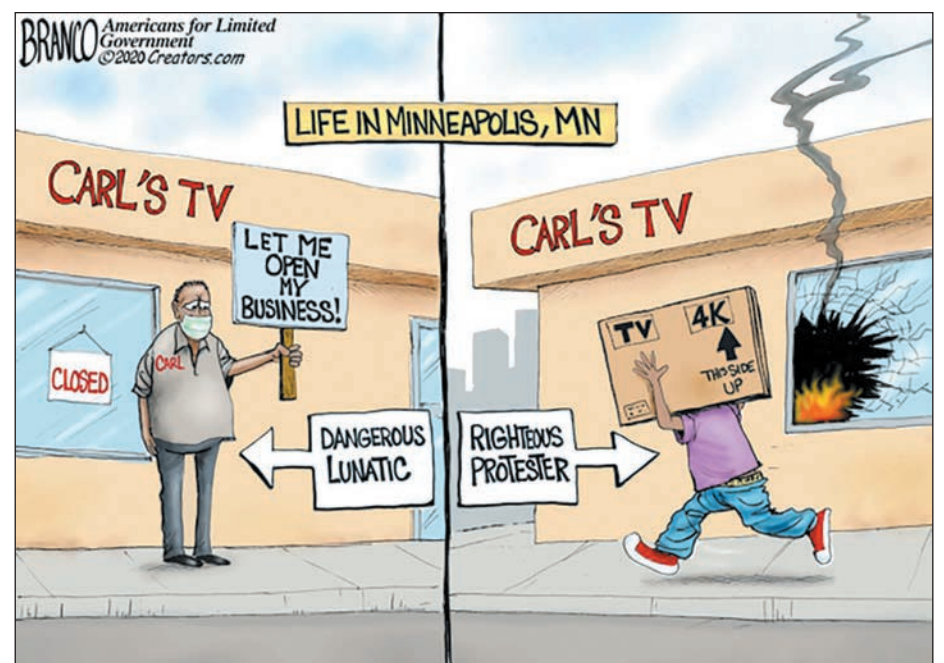
